**WHEREAS**, the Town is desirous of retaining a professional labor consultant with expertise in the area of contract negotiations;

**WHEREAS**, Daniel McKillip represents that he is qualified to provide and furnish such services to the Town. Now, therefore be it;

**RESOLVED**, the Town hereby retains Mr. McKillip to provide negotiations services, prepare proposals and counter proposals on behalf of the Town Of Plattsburgh, and be it;

**FURTHER RESOLVED**, that Mr. Mckillip serve as chief spokesperson in negotiating Labor Contracts, to prepare and represent the Town Of Plattsburgh for fact finding and arbitration if necessary, including the preparation and filing of briefs, finalizing the Contract language for printing and providing such other services directly related to the negotiations of the Town contract(s) at a rate of \$90.00 per hour plus customary expenses (IRS rate for mileage copies @ \$.20 per page, faxes received @ \$.20, sent @\$1.00 per page, long distant calls, postage etc). The hourly rate commences at the time of arrival at the business destination or for office work that includes phone calls that require follow up work, including research, as well as preparation for negotiations. Now, therefore be it;

**RESOLVED**, that the Supervisor is authorized to enter into contract with **NORTH LABOR RELATIONS ASSOCIATES, INC** (hereinafter referred to as the

“NCLRA”) with offices located at 236 Algonquin Drive, P.O. Box 96 Lake Placid New York 12946.
