WHEREAS, the original proposed site to install a master antenna at the Town Hall on the existing tower and upon review by the contractor was found to be inadequate for the antenna mount needs and the cost to replace the tower antenna and to install all necessary tower relay control equipment is estimated at \$ 6,750.00 and

WHEREAS, conditions require moving the site to the Morrisonville Water Tank, to allow a more reliable signal transmission, therefore be it
