WHEREAS, the Town retained an independent consultant to identify the most important software needs and available systems to best meet those needs; and

WHEREAS, Cristian Balan, CISSP, CHFI, Managing Consultant representing NY Computer Networks has presented his extensive needs analysis and review of systems that would best meet the Town's current and future needs; and

WHEREAS, the consultant has made recommendation that Harris Computer Systems of 5540 Porter Road, Niagara Falls, NY 14304 has the expertise and experience to provide for the Town's software needs as well as the level of training and support for the transition to new Graphical User Interface software systems; therefore be it

RESOLVED, that the Supervisor be authorized to enter into an agreement with Harris Computer Systems, as indicated by their Purchase Agreement effective 45 days from December 12, 2008, in the total amount of \$75,000 plus travel and lodging not to exceed \$3,500 inclusive of software, operating systems, application software, on/off site support, on site training, hardware and professional services less approximately \$5,000 for a new server that will be purchased by the Town at a later date; and be it further
