**Appointment Of Shelby Wright As Building  
Maintenance and Grounds Worker**

**WHEREAS**, to better meet the need of all Departments in the Town of Plattsburgh and facilitate appropriate staffing, the process of restructuring the Parks and Recreation and Building and Grounds Departments has eliminated the need for the position of Senior Building Maintenance Worker in the Parks and Recreation Department but, to maintain the Parks and Recreation buildings and grounds, restructuring created the need for an additional Building Maintenance and Grounds Worker; and

**WHEREAS**, with approval by Civil Service, the position of Senior Building Maintenance Worker has been reclassified to Building Maintenance and Grounds Worker; and

**WHEREAS**, Melanie Defayette, Town Recreation and Youth Director, has submitted a letter recommending to the Town Board that Shelby Wright, currently the Parks and Recreation Senior Building Maintenance Worker, be appointed to the new position of Building Maintenance and Grounds Worker; now, therefore be it

**RESOLVED**, Mr. Shelby Wright be appointed to the new position of Building Maintenance and Grounds Worker in the Parks and Recreation Department, effective immediately, at the rate of \$18.93 per hour, two dollars below the 2011 negotiated job rate for said position and in compliance with current Teamster Agreement negotiations and he would be on a six month probation from the date of this Resolution; and be it further

**RESOLVED**, and a copy of this Resolution be given to the Budget Officer and Melanie Defayette, Town Recreation and Youth Director and put this in Mr. Wright's personnel file.
