Discussion:

Councilor Renadette noted that a community member recently approached him with concern over another possible push for sewer system installation on Cumberland Head. Councilor Renadette stated that possible grants and low-interest loans were available for said project, but were voted down not once, but twice, by Cumberland Head residents. He insisted that the Town in no way intends to come to the Cumberland Head area with a public sewer proposal.

“If there’s ever a sewer out there, it’ll be mandated by the federal government before I vote ‘yes’ on that,” he said.

Supervisor Bassett noted that the Town would be unable to once again secure the level of funding it would take to bring such a project to Cumberland Head. Councilor Mannix concurred with Supervisor Bassett’s response, noting the extremely inordinate amount of funding that became available to complete the project, but was ultimately turned down by residents of Cumberland Head.
