**EXECUTE AN AGREEMENT BY AND  
BETWEEN THE TOWN OF PLATTSBURGH  
AND TEAMSTERS LOCAL 687**

**WHEREAS**, the Town of Plattsburgh and the Teamsters Local 687 are parties to a Collective Bargaining Agreement ("CBA") with effective dates of January 1, 2020 through December 31, 2022 and have been negotiating a successor agreement for the period of January 1, 2023 through December 31, 2025; and

**WHEREAS**, Teamsters Local 687 membership voted to ratify the terms of the Successor Agreement on April 13, 2022; and

**WHEREAS**, the attorney for the Town of Plattsburgh recommends adopting the terms of the Successor Agreement; now, therefore be it,

**RESOLVED**, that the Town Board of the Town of Plattsburgh hereby authorizes the Supervisor of the Town of Plattsburgh to execute a Successor Collective Bargaining Agreement between the Town of Plattsburgh and the Teamsters Local 687 covering the period from January 1, 2023 through December 31, 2025; and it is further

**RESOLVED**, that a copy of this Resolution be given to the Finance Manager, Shop Stewards in the Town of Plattsburgh and, the Labor Relations Teamster Representative, Mickey Smith.
