Then a copy will be given to the applicant once it is all approved.

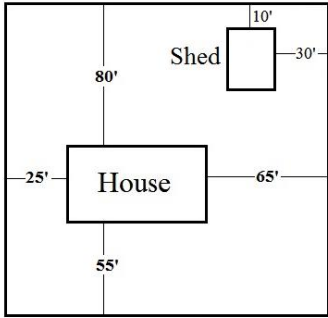
